**Site Description:** Horseshoe Lake Park is located in Woodland WA, about 25 miles north of Portland OR. The lake is calm fresh water. The test area is a sandy beach with water gradually increasing in depth. Swimming depth for the dogs is about 20 feet from the shore. We have use of a covered pavilion and a treed/shady area for setting up x-pens and crates.

**Regulations:** These Water Test are sanctioned by the Working Dog Committee of the Newfoundland Club of America (NCA) and sponsored by the Pacific Northwest Newfoundland Club (PNNC). Entrants are responsible for obtaining and reading the current regulations. The regulations were last updated March 2018. **Entries:** \$45.00 per entry per day (WD, WRD, & WRDX). Please indicate on your Test Entry form which days you are entering and which test.

**Entry Limitations:** The test is limited to a total entry of 30 dogs each day. Space will be reserved for 25 WD/WRD entries and 5 WRDX entries. A minimum entry of 2 WRDX dogs will be required for that level to be held. At closing, if any of the reserved spaces are not filled, additional entries already received in the other category will be allowed to fill the test to 30 entries total. **PLEASE NOTE:** Bitches in season will be tested at the end of the day. Per section 12 of the Water Test Regs.; *Priority will be given to entries that have not earned titles in the division entered. Titled dogs may be entered for judging if entry limits have not been filled.*

Entries post-marked prior to Thursday, July 25, 2019 for NCA Members, or Monday, August 5, 2019 for Non NCA Members will not be accepted.

Entries close and must be received by the test secretary no later than Wednesday August 28, 2019 at 6:00 PM.

In order to provide equal opportunity for all exhibitors, entries will be accepted in the order of the postmark date. In the event of a postmark tie, a random drawing will be held.

**Requalifiers** will be accepted on a "space available" basis. In other words, untitled dogs will be given first priority even if their entry is postmark after that of a titled dog. If entries fill, an alternate list will be established. Openings will be filled from the alternate list in postmarked order. In the event of a postmark date tie, a random drawing will be made. Any dog that passes the WD (Junior Division) at either test may post-enter the WRD test (Senior Division), regardless of the entry limit, for an additional \$25.00.

**Bitches in Season:** Bitches in season will be allowed to participate.

Bitches in season that are entered in any division will be judged at the conclusion of the WRDX portion of the test on Saturday and WRD portion of the test on Sunday.

**Practice:** The test site will be available for practice on Friday afternoon prior to the test. There will be no organized practice nor will there be a boat available. There will be an unofficial practice session on Saturday, September 14<sup>th</sup> at the conclusion of the day's events. A boat will be available for use. **Please Note:** Dogs are required to be on leash at all times except during the actual test. Off leash dogs are subject to fines and the Park is patrolled regularly.

**Food:** Lunch and morning hospitality will be provided to all exhibitors and stewards on the test days. Please let the Test Secretary know if additional lunches will be needed.

Saturday evening dinner's location is still to be determined. The final details will be included in the confirmation letter.

## NCA WORKING EVENT AGREEMENT

I (we) acknowledge that the NCA test regulations have been made available to me (us) and that I am (we are) familiar with their contents. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem to be sufficient. I (we) agree that I (we) will uphold the AKC Code of Sportsmanship, the NCA Code of Ethics, and (if applicable) the NCA Judges Code of Ethics. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win ribbons or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents, or test secretary and the owner or lessor of the premises or grounds and the employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the test premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim or loss of the dog by disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person or any other causes.
