## **ENTRY INFORMATION**

Online Entry Available. PNNC is using the NCA online registration program for this event. Online Registration is OPTIONAL. Entries for this test will be accepted through the NCA's online registration service at <a href="https://www.ncanewfs.org/wdc/">https://www.ncanewfs.org/wdc/</a> as well as through the traditional paper method. Entries submitted electronically will be assigned a postmark with the same date the entry is entered. Entries submitted by mail will be assigned the postmark given as per usual. Entries submitted electronically and via post will be considered equally in date order for slots in the test. For Mail Entries Please send entries, with fees (\$45.00 per entry) and a copy of the entered dog's AKC/ILP or foreign registration paper to the Test Secretary.

#### **ENTRY LIMITATIONS**

Saturday, May 17 and Sunday May 18, 2025, Entries Limited to 15 exhibitors each day.

Entries will be accepted in the Beginner Draft Dog, Draft Dog and Draft Dog Excellent tests combined (a team counts as a single entry) with 5 spaces reserved for DDX/TDDX. If there are less than 5 DDX/TDDX entries, the open spaces can be filled by BDD/DD/TDD entries and vice versa up to the total of 15 combined. If less than 3 entries are received, the tests may be cancelled. **Entries close Monday, May 5, 2025 at 11:59pm.** 

For both days, if entries fill, an alternate list will be established. Openings will be filled from the alternate list in the order received.

Re-qualifiers will be accepted on a "space available" basis. In other words, untitled dogs will be given first priority even if their entry is received after that of a titled dog.

**ENTRY FEE: \$45.00 per entry.** Please make checks payable to the **Pacific Northwest Newfound-land Club or PNNC**.

#### **MISCELLANEOUS:**

Bitches in season may participate in NCA Draft Tests. Bitches in season shall be judged at the conclusion of judging for that day. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test areas. At least one other bitch must be available to perform the group exercises with any bitches in season. If possible, this may be a bitch who has not competed in group exercises or another volunteer. Bitches that have had an ovarian sparing spay are required to be tested as "Bitches in Season."

Each Entrant is responsible for their own equipment. No carts or harnesses will be provided.

### NCA POLICY ON DOG AGGRESSION

Any dog that, in the opinion of the Event Committee, attacks a person or a dog at the NCA working event, resulting in an injury, and is believed by that committee to present a hazard to persons or other dogs, shall be disqualified. When the event committee disqualifies the dog, a report shall be filed with the NCA Board. The disqualified dog may not again compete at nor be on the grounds of an NCA working event unless and until, following application for reinstatement by the owner to the NCA Board, the owner receives official notification in writing from the NCA Board that the dog's eligibility has been reinstated.

#### **OUT OF CONTROL DOG POLICY**

## Approved NCA Board of Directors

November 11, 2023

At all NCA Events dogs must be kept under control to prevent harm to itself or others. It is the owner/handler's responsibility to ensure their dogs are under control for the duration of the event.

At NCA events dogs must be crated or leashed and collared at all times, except when the dogs are required to perform off leash. When dogs are leashed, the length of the leash must not exceed SIX (6) feet and the leash may NOT be a retractable leash.

Dogs should not be allowed to approach another dog without permission from the other dog's owner/handler.

Any dog that, in the opinion of the judges, event committee or designated safety officer representing the event, appears dangerous, shall be asked to leave the event promptly or be crated for the duration of the event and is excused from further participation in the event. Anyone who witnesses a dog appearing to be dangerous should bring their concerns to the judges, event committee or safety officer. Part of upholding good sportsmanship is to take action through the appropriate channels.

Examples of out of control behavior would include but are not limited to:

Aggressive vocalization such as barking and growling, or aggressive behavior toward any person or animal such as snapping, biting, lunging, charging, attacking or attempting to attack at any time while on the test grounds.

Owners and handlers are responsible for monitoring the well-being and safety of their dog(s). If left unattended the owner/handler must check on them frequently to ensure they are safe.

If the dog is excused from the test grounds for aggression, the automatic grievance policy of the NCA is enacted. If an injury to a dog or person occurs, the AKC Rules Applying to Dog Shows Ch 11, section 15 goes into effect. (References, chapter 2, section 14 in both water and draft regulations)

#### **REGULATIONS**

Regulations in effect for these tests are the approved NCA Draft Test Regulations revised May 2022 and effective July 1, 2022, as available on the NCA Website.

#### **TEST SITE:**

**Description:** The draft test rules state that the handler should use equipment suitable for the test terrain.

Champoeg's acres of forest, fields and wetlands recreate the landscape of a bygone era. The test site consists of varied terrain, including damp grassy areas, wooded paths, gravel and paved areas. The freight haul may include gentle and moderate hills and may be near water and an active campground. There may be some uneven areas on the grounds with the possibility of gopher holes. Spring in the Pacific Northwest can have varied weather throughout a given day. Prepare for both rain, wind and cold weather. Anyone having further questions concerning the test site should contact the test secretary for details.

#### **DIRECTIONS TO THE TEST SITE:**

**Champoeg State Park** is located off the I-5 near Newberg Oregon which is approximately 25 miles north of Salem, Oregon and about 25 miles south of Portland Oregon

**From the South:** I-5 North towards Salem/Portland, take exit 263 towards Brooks/Gervais. Turn Left onto Brooklake Rd NE toward Willamette Mission State Park/Hopmere. Turn Right onto River Rd NE. Continue onto French Prairie Rd NE. Turn Right onto Champoeg Rd NE. Turn Left onto Champoeg State Park. Destination will be on your left. Once in park, continue straight and follow signs to campground. Group Camping Area.

**From the North**: I-5 South. Take Exit 278 onto Ehlen Rd toward Newberg. Turn Right onto Ehlen Rd. NE toward Donald/Champoeg State Park. Turn Right onto Case Rd NE. Continue onto Champoeg Rd. NE. The destination will be on your right. Once in the park, continue straight and follow signs to campground. Group Camping Area.

Parking at the Test Site: Champoeg State Park charges \$5.00/day or Annual State Park Permit.

**Practice:** The Test Site is open to the public and you may practice from 8am - Dusk any day before the test. On Friday before the test, we will have a few maneuvering items set up at 5:00pm for practice. Parking fees apply. Please observe the Park's "leash required" policy unless in the marked off leash dog park area.

## **ACCOMMODATIONS:** Please be sure to confirm Pet Policies when making reservations.
