Draft Dog Excellent Test Weight Exchange.

The weight exchange for the DDX test is two 15lb bags of kibble.

The dimensions are 21" X 14" X 2.5" per bag.



Eligibility

NCA draft tests are open to only purebred Newfoundland dogs of either sex that are at least 18 months old on the date of the test. Other restrictions listed in the NCA rules also apply. Bitches in season are allowed but will be tested after all other entrants have been tested that day. Please inform a test committee member as soon as possible if you will be bringing a bitch in season to the test. They must be crated away from other dogs in an area designated by the test committee. At least one other bitch must be available to perform group exercises with any bitch in season. Bitches that have had an ovarian sparing spay are required to be tested as "Bitches in Season".

Note: Dogs or handlers suspended from AKC are unable to enter NCA events and dogs suspended from AKC events are not allowed on test grounds.

ENTRY INFORMATION

Entry fee is \$45.00 for all single or team entries.

Early Entries will be accepted from **NCA members online or postmarked Friday April 17th 2026 until closing.**

Entries will only be accepted from **non-NCA members online or postmarked Monday April 27th 2026 until closing.**

All entries close at 11:59pm on Saturday May 23rd 2026. After that time, entries cannot be accepted, canceled, altered, or substituted.

NCA members are granted a 10-day early entry as a benefit of their membership in the NCA. To take advantage of the early entry rule, if the dog is co-owned, either all co-owners of the dog must be NCA members OR the handler must be an NCA member.

Online Entry:

The preferred method of entering the draft tests is online at: <https://www.ncanewfs.org/wdc/>. If you are an NCA member, you will provide your login and password. If not a member, you will provide the same contact information that you would provide on a paper entry. You will need to upload a copy of your dog's registration certificate, so please create an electronic version of that document ahead of time. You will be prompted for your credit card information to

complete the entry. If you need to pull or change your entry later, that must be done through the test secretary and not using the online entry tool.

Entry Processing

Entries will be accepted on-line or by mail. Entries submitted electronically will be assigned a postmark with the same date the entry is entered no matter the time of day. Entries submitted by mail will be assigned the postmark given as per usual. Entries submitted electronically and via post will be considered equally in date order for slots in the test. Priority will be given to entrants who have not earned titles in the Division entered.

If the number of entries with the same date exceeds the number of available slots, a drawing will take place to fill the vacancies and determine the alternates. All entries received after the entry limit has been reached will be placed on an "alternate list" by order of those without titles, in order of postmark or online entry, followed by requalifiers in order of postmark or online entry. If withdrawals or absences occur prior to the start of the test, the test secretary will substitute entries from the alternate list. When notifying exhibitors of their entry numbers, exhibitors on the alternate list will be notified of their position on the list.

Entry Limitations

Saturday, June 6 and Sunday June 7, 2026: **Entries Limited to 15 exhibitors each day.**

Entries will be accepted in the BDD/DD/DDX combined (a team counts as a single entry) with 5 spaces reserved for DDX/TDDX. If there are less than 5 DDX/TDDX entries, the open spaces can be filled by BDD/DD/TDD entries and vice versa up to the total of 15 combined. If less than 3 entries are received, the tests may be cancelled.

TEST SITE:

Description: The draft test rules state that the handler should use equipment suitable for the test terrain.

Champoeg State Park is a public park. Situated on the South bank of the scenic Willamette River. Champoeg's acres of forest, fields and wetlands recreate the landscape of a bygone era. The test site consists of varied terrain, including uneven, damp grassy areas, wooded paths, gravel and paved areas. The freight haul may include gentle and moderate hills and may be near water and an active campground. There may be some uneven areas on the grounds with the possibility of gopher holes. There is a disc golf course adjacent to the test site. The average temperature at Champoeg in June a typical day ranges from a high of 70°F (21°C) to a low of 49°F (9°C), with some humidity. On average there is a 23% chance of light rain. Rare heat waves in the upper 90's have been recorded as early as May.

Anyone having further questions concerning the test site should contact the test secretary for details.

Practice: The Test Site is open to the public and you may practice from 8am - Dusk any day before the test. On Friday before the test, we will have a few maneuvering items set up at 5:00 pm for practice. Parking fees apply. Please observe the Park's "leash required" policy unless in the marked off leash dog park area.

Directions to the Test Site:

Champoeg State Park is located off the I-5 near Newberg Oregon which is approximately 25 miles north of Salem, Oregon and about 25 miles south of Portland Oregon

From the South: I-5 North towards Salem/Portland, take exit 263 towards Brooks/Gervais. Turn Left onto Brooklake Rd NE toward Willamette Mission State Park. Turn Right onto River Rd NE. Continue onto French Prairie Rd NE. Turn Right onto Champoeg Rd NE. Turn Left onto Champoeg State Park. Go straight at the kiosk for .5 mile. Turn left towards oak grove picnic area. Oak grove #4 is the one with the large shelter.

From the North: I-5 South. Take Exit 278 onto Ehlen Rd toward Newberg. Turn Right onto Ehlen Rd. NE toward Donald/Champoeg State Park. Turn Right onto Case Rd NE. Continue onto Champoeg Rd. NE. The destination will be on your right. Go straight at the kiosk for .5 mile. Turn left towards oak grove picnic area. Oak grove #4 is the one with the large shelter.

Parking at the Test Site: **Note rate increase:** Champoeg State Park charges \$10.00/day for in-state residents and \$12.00/day for out-of-state residents, or annual State Park Permit.



National Black Bear Day: Oregon is home to nearly 30,000 black bears, *Ursus americanus*, America's most common bear species. Exhibitor Responsibilities

Each exhibitor is responsible for providing his/her own proper equipment. Each exhibitor is responsible for the knowledge of the official NCA Regulations governing a Draft Test and the applicable Standards of Performance. Regulations can be downloaded from the NCA website by choosing Draft Test Regulations on the page www.ncadogs.org/forms

All dogs not currently being tested should always be leashed or crated. They cannot walk any maneuvering or freight haul courses except during official course familiarization times. As a courtesy to other entrants, please try to keep your dogs quiet.

Waiver of Rights - Animals in Distress

The Newfoundland Club of America, Inc, and the regional club hosting this event reserves the right to remove any animal in distress from a parked vehicle or crate, and all people attending this dog event hereby waives any claim for damages against the Club for such removal. The NCA regards the health, safety, and life of any dog on the event grounds to be paramount to other property or privacy rights. If the owner cannot be found in a timely manner, we will take whatever action is necessary for the safety of the dog, which may include breaking windows to enter a vehicle. Dogs found in an unsafe environment, distress, or in harm's way (for example, left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress, or harm's way is considered mistreatment and subject to appropriate discipline

Spectators and Unentered Dogs

Spectators, as well as well-behaved unentered dogs (except bitches in season), are welcome at the CNC Draft Test. Unentered dogs will not be permitted near the test site area. The Safety Officer is responsible for ensuring that all unentered dogs are kept outside and away from the test site. As a courtesy to our exhibitors, we ask that all dogs be kept quiet and leashed or crated. No dogs are allowed to be kept in closed vehicles even if the air conditioning is running. If a dog is in a vehicle, the vehicle must have at least one open window, door, or hatchback. The Safety Officer will remind everyone of this policy and will check vehicles in the parking area throughout the day.

Bitches in Season

Bitches in season may participate in NCA Draft Tests. Bitches in season will be tested at the end of the competition after all male dogs are judged. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test areas.

NCA POLICY ON DOG AGGRESSION

Any dog that, in the opinion of the Event Committee, attacks a person or a dog at the NCA working event, resulting in an injury, and is believed by that committee to present a hazard to persons or other dogs, shall be disqualified. When the event committee disqualifies the dog, a report shall be filed with the NCA Board. The disqualified dog may not again compete at nor be on the grounds of an NCA working event unless and until, following application for reinstatement by the owner to the NCA Board, the owner receives official notification in writing from the NCA Board that the dog's eligibility has been reinstated.

OUT OF CONTROL DOG POLICY

Approved NCA Board of Directors

November 11, 2023

At all NCA Events dogs must be kept under control to prevent harm to itself or others. It is the owner/handler's responsibility to ensure their dogs are under control for the duration of the event.

At NCA events dogs must be crated or leashed and collared at all times, except when the dogs are required to perform off leash. When dogs are leashed, the length of the leash must not exceed SIX (6) feet and the leash may NOT be a retractable leash.

Dogs should not be allowed to approach another dog without permission from the other dog's owner/handler.

Any dog that, in the opinion of the judges, event committee or designated safety officer representing the event, appears dangerous, shall be asked to leave the event promptly or be crated for the duration of the event and is excused from further participation in the event. Anyone who witnesses a dog appearing to be dangerous should bring their concerns to the judges, event committee or safety officer. Part of upholding good sportsmanship is to take action through the appropriate channels.

Examples of out of control behavior would include but are not limited to:

Aggressive vocalization such as barking and growling, or aggressive behavior toward any person or animal such as snapping, biting, lunging, charging, attacking or attempting to attack at any time while on the test grounds.

Owners and handlers are responsible for monitoring the well-being and safety of their dog(s). If left unattended the owner/handler must check on them frequently to ensure they are safe.

If the dog is excused from the test grounds for aggression, the automatic grievance policy of the NCA is enacted. If an injury to a dog or person occurs, the AKC Rules Applying to Dog Shows Ch 11, section 15 goes into effect. (References, chapter 1, section 7 in draft regulations)
